BIOGRAPHICAL NOTE

Bernard Law Montgomery was born on the 17th November 1887 in Surrey, England. In 1889 his father became the Bishop of Tasmania and Montgomery and his eight siblings lived in Australia until returning to England in 1897. After overseas service in India, Montgomery became a senior British Army officer in First World War and Second World War. Commanding the British Eighth Army and the 21st Army Group in significant campaigns in France, North Africa, Italy and the Western Front, earned him a Distinguished Service Order, the Knight Grand Cross of the Order of the Bath and the Knight of the Order of the Garter. Post war he became Chief of the Imperial General Staff and served as NATO'S Deputy Supreme Allied Commander Europe before his death in 1976 at the age of 88.

The original Montgomery Papers were sold by the Field Marshal to Thomson Newspapers in 1962, and subsequently presented to the Imperial War Museum by Sir Denis Hamilton on behalf of the International Thomson Organisation in 1982. The collection was catalogued (PP/MCR/C30) and a detailed listing created by Stephen Brooks (IWM) in 1986. In 1993, a microfilm copy of the papers was created and purchased by the School of HASS, UNSW Canberra for the purposes of research by its staff and students.
